### EFSA statement on the contamination of sunflower oil with mineral oil exported from Ukraine

The European Food Safety Authority (EFSA) received a fax on 28<sup>th</sup> of April 2008 from the European Commission, DG Health and Consumers requesting a rapid assessment concerning contamination of sunflower oil with mineral oils. EFSA took immediate action, and provided an initial view to the European Commission on the same day. This view was neither a risk assessment nor a fast-track advice and was only based on a limited set on data available at this point in time.
